### Section: 4. FIRST AID MEASURES

### Section: 6. ACCIDENTAL RELEASE MEASURES

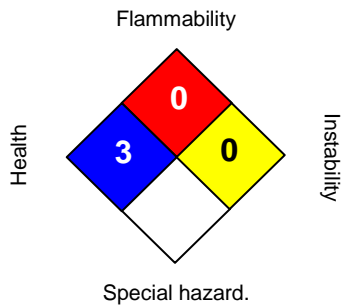
